SUBJECT: Third Party Liability Information on ISD2

Due to a change in transmission of Third Party Liability (TPL) information from the State's fiscal agent, ACS, the ISD2 eligibility system will no longer reflect current TPL information. You will see a message when you sign into ISD2 to this effect. We will also put a message on the HPME screen that the information will not be updated after 05/05/09. TPL information will now be provided directly from the State's fiscal agent, ACS.

To get current information about an applicant/recipient's TPL, eligibility, or enrollment in SALUD!, a designated individual in your ISD office will be able to access the Medicaid information system through a special web based portal. ACS has already granted permission to certain users in each ISD field office and will be busy signing up other designated users throughout the month. See Attached EXCEL spreadsheet of staff listed by county office who have log-on capabilities. Requests should be made to your own county's contact person.

The new system will give the user: Eligibility (COE, Benefit Description, Co-pay), Lock-in, Medicare, TPL, and Long Term Care Information. This information will be applicable only for the Date of Service requested by the ISD worker. If a Date of Service is not entered, the system will default to the current date. The information is applicable to a "point in time" and not a range.

Also attached to this GI are five examples (screens) of the information and how it will look on the web portal. This information will be more current than the information found in the HPME system, but date specific.


