**AMENDMENT No. 7**

This Amendment No. 7 to PSC: 18-630-8000-0035 (the “Agreement” or the “Contract”) is made and entered into by and between the **New Mexico Human Services Department** (“HSD”); the **New Mexico Behavioral Health Purchasing Collaborative** (the “Collaborative”); and **Western Sky Community Care, Inc.** including any successors and/or assignees (“CONTRACTOR”); and is to be effective upon signatures by all parties.

**WHEREAS**, there are certain revisions to the Contract that are necessary.

**UNLESS OTHERWISE SET OUT BELOW, ALL OTHER PROVISIONS OF THE ABOVE REFERENCED AGREEMENT REMAIN IN FULL EFFECT AND IT IS MUTUALLY AGREED BETWEEN THE PARTIES THAT THE FOLLOWING PROVISIONS OF THAT AGREEMENT ARE AMENDED AS FOLLOWS:**

**Section 7.4, Agreement Term, Paragraph 7.4.1, is amended to extend the termination date, to read as follows:**

This Agreement, including any amendments and any changes made by notice to adjust the capitation rates, shall be effective upon signature of all parties and will terminate on June 30, 2024. Thereafter, HSD reserves the right to renew this Agreement for an additional one-year period(s), not to exceed 8 years for the total contract period.
